Adoption of the agenda and other organizational matters

Proposed organization of work

1. The third session of the Commission on Sustainable Development acting as the preparatory committee for the World Summit on Sustainable Development will be primarily devoted to further consideration, elaboration and negotiations on elements for decisions contained in the Chairman's paper. For that purpose, three working groups will be established to conduct the work of the session, as described below. In accordance with established practice, not more than two working groups will meet simultaneously.
2. Working Group I will focus on the first four sections of the Chairman's paper (A/CONF.199/PC/L.1, annex), namely, introduction; poverty eradication; changing unsustainable patterns of consumption and production; and protecting and managing the natural resource base for economic and social development.
3. Working Group II will focus on the next five sections of the Chairman's paper, namely, sustainable development in a globalizing world; health and sustainable development; sustainable development of small island developing States; sustainable development initiatives for Africa; and means of implementation.
4. Working Group III will focus on strengthening governance for sustainable development at the national, regional and international levels.
5. A proposed timetable for the session is contained in the annex.
