### **Status of documentation for the session**

#### **Note by the Secretary-General**

1. In Economic and Social Council resolutions 1979/1 and 1979/69 on the control and limitation of documentation and 1988/77 on the revitalization of the Council, the Council reiterated that the Secretariat should circulate the relevant documentation in all the working languages six weeks before the opening of the sessions of the Council and its subsidiary organs, and invited the Secretariat to take steps to ensure effective compliance with rule 13, paragraph 4, of the rules of procedure of the Council.
2. In resolution 1979/69, the Economic and Social Council decided to request the Secretariat to inform the Council and its subsidiary bodies, in the relevant annotated agenda, which documents had not been issued in accordance with the six-week rule, with a full explanation of the reasons that had prevented their circulation.
3. In view of the schedule of the organizational session of the preparatory committee for the World Summit on Sustainable Development (30 April-2 May 2001), the documentation for the session should have been submitted to the General Assembly and Economic and Social Council Affairs Division of the Department of General Assembly Affairs and Conference Services of the United Nations Secretariat by 19 January 2001 and circulated by 19 March 2001. The documents not circulated by that date are listed in the annex to the present note.
